### Practice Overview

#### Notable and Reported cases

- Operation Hallett
  - **R v Corry (2015 – ongoing)**. Defence counsel for Corry charged with conspiracy to supply cannabis (186kgs located, 16 defendants).
  
- Operation Mint
  - **R v Martin (2015 – ongoing)**. Defence Counsel in large scale drugs conspiracy involving cocaine and mephedrone. Complicated Proceeds of Crime Application due to property recovered from the defendant and evidencing legitimate income.
  
- Operation Kinsfolk
  - **R v Quick et al (2010-2015)**  
Junior Counsel prosecuting on behalf of the Organised Crime Division of the CPS. Multi million pound drugs conspiracy, 11 defendants faced trial, the indictment contained both drugs and money

laundering offences. The case also involved allegations of conspiracy to supply Class A drugs to Australia. Sole conduct of the Proceeds of Crime Applications, the value of drugs involved exceeded £10m.

- Operation Denver
  - **R v Pryzborowski (2011)**  
Defence Counsel in drugs conspiracy involving a kilo of heroin being seized from a vehicle in which the defendant was travelling.
  
- Operation Rebus
  - **R v Cureton (2010)** Defence Counsel in drugs conspiracy.
  
- Operation Balneation
  - **R v McNess et al (2008 – 2011)** - Junior Counsel prosecuting on behalf of the Organised Crime Division of the CPS. Drugs conspiracy involving Class A and Class B drugs. The Proceeds of Crime applications involved multi million pounds worth of realisable assets.
  
- R v Hamza 2016  

'Fresher's Week Rape' – prosecuting
  
- R v Harry 2015  

Defence Counsel in allegations of rape made by former partner, multiple allegations of violence admitted as 'background evidence'.
  
- R v Cox 2015  

Defence Counsel for defendant who pleaded guilty to 2 counts of robbery of high street banks at knife point
  
- R v Coslett 2014  

Defence counsel for first named defendant on the indictment in an allegation of manslaughter, the case attracted significant press interest.

- R v Owen 2014  

Prosecution Counsel in case alleging multiple rapes of children by a convicted rapist
  
- R v Batten 2013  

Prosecution Counsel in case involving allegations of historical sexual abuse. Leave to appeal against

conviction granted, conviction upheld by the Court of Appeal.

- R v Donovan and Gibbons 2013

Defence counsel, case involved allegations of robbery in the victims home, one victim left with permanent brain injury, unable to continue work as a General Practitioner
