    - Amber Energy Consultants Ltd v. Electron Ltd [2015] Multi-track contract case on issues surrounding commission.
    - Wish Communications Ltd v. Trusting Hands [2009] Multi-track commercial contract case on the interpretation of terms in mobile phone contracts
    - Wildig Lammie Partnership LLP v. Bartondale Wattsville Ltd [2011] Multi-track commercial contract case on the interpretation of capped fee clause
    - B v. E and A [2012] High Court chancery trial. Application to set aside a transaction at an undervalue pursuant to section 238 of the Insolvency Act 1986. After hearing evidence the Judge found that the transaction should be set aside and found that A had transferred the property to E in order to avoid paying a judgment due to B from a previous case.
    - S v. K [2012] High Court chancery trial. An application for declaratory relief that a power of attorney had been forged by family members. After a two day trial the Judge found that the power had been forged and gave the declaration sought.
    - Re: W [2012] Probate. Application to distribute estate pursuant to intestacy rules.
  
  - Administrative & Public Law
    - R (on the application of GS and others) v. Cardiff City Council [2012]. Judicial Review. Oral permission hearing before Bean J. An application to have the Council's taxi licensing system declared unlawful.



- Employment
  - *Lawless v Print Plus* (2010) UKEAT/0333/09/JOJ The Employment Appeal Tribunal commented upon the factors to be taken into account when considering whether it was just and equitable to award an uplift of more than 10 per cent to a compensatory award for an employer's failure to follow the statutory dismissal procedure
  - *LR v. Blaenau Gwent C.B.C.* [2009] Constructive dismissal after allegations of an unfair promotion due to an extra-marital affair
  - *DA & AH v. Powys Local Health Board* [2010] Represented a registered nurse and care worker alleged to have physically abused patients in their care. The Tribunal found that they had been unfairly dismissed
  
- Immigration & Asylum
  - *R (on the application of Saleh Ammo) v. Secretary of State for the home Department* [2012]. Judicial Review. Oral Permission hearing before HHJ Seys-Llewellyn QC on whether the removal of the Applicant pursuant to Dublin II was lawful.
  - Appears in the First Tier and Upper Tribunal consistently in all manner of immigration cases from asylum, deportation, immigration, Article 8 and EEA cases.
  
- Personal Injury & Clinical Negligence
  - *L v. DWP* [2014] Advising Claimant who was a quadriplegic para-athlete on quantum in a claim for personal injuries in case with the potential to be worth over £1m.
  - *D v. Royal Mail* [2014] High value case involving complex shoulder injury and losses for life.
