The type of personal information we collect

We currently collect and process the following information:

- I collect and process information which is sent to me about the clients that I have been asked to represent by all solicitors who instruct me. This includes personal data and special category personal data such as medical records and criminal records.

How we get the personal information and why we have it

Most of the personal information we process is provided to me directly by you for one of the following reasons:

- To advise and represent lay clients in current or contemplated court proceeding.

[If applicable] We also receive personal information indirectly, from the following sources in the following scenarios:

- Local Authorities in order to represent lay clients in current or contemplated court proceeding.
- We use the information that you have given us in order to represent lay clients in current or contemplated court proceeding.

We may share this information with Judges and the representatives of other parties to proceedings in the same case.

Under the UK General Data Protection Regulation (UK GDPR), the lawful bases we rely on for processing this information are:

(a) Your consent. You are able to remove your consent at any time. You can do this by contacting the clerks at 30, Park Place, Cardiff.

(b) I have a contractual obligation.

(c) I have a legal obligation.

(d) I have a vital interest.

(e) I need it to perform a public task.

(f) I have a legitimate interest.

Tell people how you collect their personal information and where you collect the information from.

How we store your personal information

Your information is securely stored. It is not stored on any electronic device in my possession but on Dropbox currently but will be moved to Microsoft OneDrive later in 2023.

I keep **Case Documents** for **7 years**. I will then dispose your information by **deleting it**.

Tell people how or where you keep their personal information, how long you intend to keep it for and then how you intend to securely destroy or dispose of it. You need to do this for every type of information you hold.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
