- Operation Ulysses (2017) – Junior Counsel prosecuting multi million pound conspiracies to supply Heroin, Cocaine, MDMA, Ketamine, Cannabis. This case involved over 30 Defendants and over 60,000 pages of evidence. Highest sentence imposed on a drugs gang in Wales totalling over 200 years.
