### Practice Overview

---

Jane's reputation as a highly effective advocate and shrewd tactician extends beyond Wales and throughout England. Prior to her recent return to 30 Park Place following several years in London she has been ranked as a leading London silk in addition to her ranking for Wales. Jane's wealth of experience of the most complex aspects of children cases ensures an extensive fund of knowledge and a calm and confident approach. Jane is recognised for her particular expertise in cases concerning complex medical evidence, such as:

- Non Accidental death/catastrophic injury to a child
- Non Accidental Head Injury (NAHI), formerly known as "Shaken Baby Syndrome"
- Genetic disorders, vitamin deficiencies and congenital malformations which can raise concerns of child abuse cases due to suspicious "injuries" which give the appearance of having been inflicted
- Allegations of "honour based killing" and forced marriage
- Suspected radicalisation cases
- Sexual abuse: inter and intra familial sexual abuse
- Child protection cases involving concurrent criminal prosecution for murder/ attempted murder/ child cruelty and neglect
- Fabricated Induced Illness (FII) allegations
- Significant harm arising from parenting difficulties experienced by parents with learning/ mental health or other forms of disability
- Cases involving the representation/cross examination of a child or vulnerable adult and working to the Recommendations of the Report of the Vulnerable Witness and Children Working Group, the Advocates' Gateway and the use of Court Appointed Intermediaries

#### In Private Law

Jane has a particular interest in cases concerning the relocation of children, whether internationally or within the jurisdiction and chaired the 2015 Hanson Renouf/ALC conference in Jersey on the International Relocation of Children, also presenting her own paper on behalf of the Association of Lawyers for Children on the "Child's Perspective on Relocation".

She accepts instructions in cases of International Child Abduction and also acts for parents in other complex



private law disputes concerning their children.

Jane is an excellent communicator who combines the provision of realistic advice with total commitment to her client's case as an advocate. She has a commanding and engaging court presence, laced with charm and a lightness of touch, which inspires confidence. Her sound judgment and eye for detail contribute to her tactical awareness. - Re: Y (No 3) [2016] EWHC 503 (Fam)

Fact Finding judgment in case concerning a family group detained in Turkey suspected of trying to take their children into war torn Syria. Issues re possibly radicalisation. Munby LJ.

- X (Children) and Y (Children) [2015] EWHC 2265 (Fam).

Suspected radicalisation case with risk of flight from jurisdiction. First case of the use of electronic GPS tagging used in Family jurisdiction. Munby LJ

- Re L (Application to Withdraw) (Head Injuries: Unknown Cause) [2015] EWFC 67.

Jane represented a father suspected of inflicting a head injury on his baby, by probing the medical evidence to highlight unusual features in the clinical findings and deficiencies in the clinical management of the baby's care, resulting in the withdrawal of the Local Authority's case at the conclusion of the medical evidence. Her detailed analysis of the medical records resulted in the application being withdrawn at the close of the Local Authority's case.

- In re: B (A Child) (Care Proceedings: Habitual Residence) [2013] EWCA Civ 1434 [2013] WLR(D) 461.

Jane represented the child in a case where the Court of Appeal overturned the first instance determination of habitual residence in the High Court.

- Re E (Withdrawal of Care Proceedings) 2013 EWHC 2400.

Necessity for a robust analysis of the evidential basis of an application and guidelines for Emergency Removals and s20 agreements. Jane successfully dismantled the Local Authority's case against her client who was alleged to have tampered with essential medical equipment required for her daughter's survival. Local Authority withdrew their case at the conclusion of their own evidence.

Mrs Justice Theis DBE stated at paragraph 7 of her judgment:

'All of the advocates have conducted this hearing to the highest standard; in particular Mrs Crowley Q. C., on behalf of the mother, for her detailed, well targeted and extremely effective cross examination which turned the case round from what it first appeared to be on paper. This case has illustrated the vital importance of advocates who are experienced in undertaking this work and the value of the forensic process. Without that expertise and this process the outcome in this case could have been very different, which would have been detrimental to E's welfare.'

- In the matter of A (A Child) [2012] UKSC 60.



Jane appeared in the Supreme Court where she successfully represented a father whose contact to his own child had been stopped because of an allegation of historic sexual abuse made against him by a very vulnerable individual who did not wish her identity to be disclosed to him and sought protection under the Human Rights Act. The issue for the court was how to balance the various conflicting Human Rights issues arising.

## Family Dispute Resolution

Although not a formally qualified mediator Jane has been requested by solicitors to undertake mediation sessions in children disputes.

Her considerable experience as a Deputy High Court Judge and a Recorder equips her particularly well for Early Dispute Evaluation work.
