Practice Overview

Sam is listed as a leading junior in the Legal 500 Directories in chancery, personal injury, and clinical negligence. Alongside his busy court commitments he has a heavy paperwork practice, mainly on the multi-track.

Sam endeavours to be as accessible as possible to professional clients from the outset of proceedings to their conclusion and is viewed by many of his instructing solicitors as an extension to their own team. The directories note that "solicitors have been impressed by his advice and pleadings for years", continuing to instruct him "in increasingly complex matters", noting him to be "extremely thorough" with an "exceptional manner with clients".

Sam accepts CFA instructions where appropriate (limited to personal injury, clinical negligence, police, and Inheritance Act 1975 matters). Much of his practice is based in North Wales and he travels nationwide to attend Court hearings and mediations, as well as regularly providing training for professional clients in his specialist areas.

Sam accepts instructions on a direct access basis and is also an ADR Group accredited mediator.

Away from work Sam is a keen road cyclist and also follows the travails of Plymouth Argyle FC.

Sam is predominantly instructed on the multi-track. He represents both Claimants and Defendants (mainly



Claimants). He is often instructed in complex matters including brain injuries and complex regional pain syndrome. In legal directories he is described as "passionate and dedicated", with "a great sense of judgment" and "advice always concise and straight to the point". He was recently instructed on behalf of the Claimant in a matter that settled for £300,000, and regularly drafts schedules of loss valued in the same sort of region.

A case of Sam's was recently published in the Law Society Gazette, which is thought to be the first judicial finding of dishonesty against a defendant sounding in the disapplication of fixed costs: <u>Claimant in PI case beats fixed</u> costs by proving defendant's dishonesty | Law Gazette

Clinical Negligence

Sam's current clinical negligence instructions include a hypoxic brain injury consequent to negligent midwifery (led junior to Lloyd Williams KC). He appreciates the importance of thorough conferencing with instructed experts, and is experienced at quickly getting to grips with medical terminology and principles and exploring difficult medical aspects of liability and causation.
