## Notable and reported cases

- Re P-S (Children) [2013] EWCA Civ 223 – Led junior in a case on whether a competent child has the right to give evidence in relation to welfare issues concerning himself.
- Re L-W [2019] EWCA Civ 159 – Junior for the Local Authority in a case concerning the components of a failure to protect finding. The Court of Appeal said the following about Claire: “Finally, I would like to express the Court’s gratitude to Ms Williams who represented the Local Authority. Ms Williams, having understandably anticipated responding to the appeal, found herself, at the Court’s request, addressing the Court first. Ms Williams was of immeasurable assistance to the Court in helping us to understand much of the chronology which was not obvious from the papers.
