- Re W.L (2014) A young woman suffered a high-level C5/6 spinal injury in an RTA. The case settled on a provisional basis for £8.2 million.
- Re F (2014) A motorcyclist was rendered paraplegic following RTA. The case settled for £2.6 million gross.
- Re A.G (2013) A middle-aged man suffered severe head injuries in a motorbike accident. The case settled for £3.3 million.
