### Notable and reported cases

- Powys County Council v AB & Ors [2024] EWHC 3207 (Fam) Represented the local authority in complex care proceedings involving fabricated induced illness.
- Re C (Children) [2016] EWCA Civ 374 Led junior in the Court of Appeal for the local authority in a widely reported case involving a mother's appeal against the refusal to allow her to name her twin children "Cyanide" and "Preacher".
- EB (A Child: Care Order and Placement Order) [2016] EWHC 887 (Fam) Acted for the child in care proceedings concerning cross-border



allegations that the mother had attempted to hand over the baby to another family after travelling from Spain.

- Pembrokeshire & James [2021] EWFC 71 Instructed on behalf of the local authority in care proceedings following the murder of a child, involving parallel criminal and family proceedings.
- Edkins v Hopkins & Ors [2016] EWHC 2542 (Ch) Represented beneficiaries in a contested probate claim involving a £2 million estate. The case raised issues of undue influence, testamentary capacity, and knowledge and approval.
- Edkins v Hopkins & Ors [2017] WTLR 39 Appeared before HHJ Jarman KC (sitting as a High Court Judge) in further proceedings involving the same estate, with contested issues relating to will validity and costs.
